310.4	Office Walkthrough	Enclosed office that provides access to a private office, not necessarily assigned to people who would describe themselves in a receptionist role. Singular or multi occupant.

400	Study Facilities	Study space is classified into five categories: study room, stack, open-stack study room, processing room, and study service. Offices used for library activities are coded as office facilities. A study space may contain equipment or materials that aid the study or learning process (e.g., computers, multimedia carrels, CD and DVD players, typewriters, records and tapes) and that do not restrict the space to a particular academic discipline or discipline group. 525.8	Private Lounge	A lounge space that directly serves an Athletic or Physical Education facility. This is a private lounge with restricted access and is not accessible to the general public.
525.9	Kitchenette	A kitchenette that directly serves an Athletic or Physical Education facility. This is a private kitchenette with restricted access and is not accessible to the general public.
530	Media Production	A space used for the production or distribution of multimedia materials or signals.
535	Media Production Service	A space that directly serves a media production or distribution space as an extension of the activities in that facility.
540	Clinic	A space used for providing diagnosis, consultation, treatment, or other services to patients or clients or subjects with a primary purpose of instruction, research, or public service.
545	Clinic Service	A space that directly serves a clinic as an extension of the activities in that space.
550	Demonstration	A room or group of spaces used to practice, within an instructional program, the principles of certain disciplines such as teaching, child care or development, and family and consumer science.

555	Demonstration Service	A space that directly serves a demonstration facility as an extension of the activities in that facility.
560	Field Building	A barn or similar agricultural structure used for animal shelters or for the handling, storage, or protection of farm products, supplies, vehicles, or implements.
570	Animal Facilities	A space that houses laboratory animals used for research and/or instructional purposes.
575	Animal Facilities Service	A space that directly serves an animal quarters facility as an extension of the activities in that facility.
580	Greenhouse	A building or space, usually composed chiefly of glass, plastic, or other light-transmitting material, that is used for the cultivation or protection of plants or seedlings for research, instruction, or campus physical maintenance or improvement purposes.
585	Greenhouse Service	A space that directly serves a greenhouse facility as an extension of the activities in that facility.
590	Other	A category of last resort.
591	Quality Of Life Room	Private space accommodation dedicated to a special use.
591.1	Lactation Room	Private space accommodation for parents who are nursing.
591.2	Prayer/Meditation Room	Private space accommodation for prayer, meditation and or reflection.

600	General Use Facilities	A space designed and equipped for the assembly of many persons for such events as dramatic, musical, devotional, livestock judging, or commencement activities
610	Assembly	A space designed and equipped for the assembly of many persons for such events as dramatic, musical, devotional, livestock judging, or commencement activities
610.1	Chapel	A space used for religious services.
610.2	Non-Class Auditorium	Auditorium/Assembly room used for a non-class presentations and performances.
615	Assembly Service	A room or area that directly serves an assembly facility as an extension of the activities in that facility.
615.1	Storage Room	A storage space that directly serves an Assembly room or rooms.
615.2	Assignable Circulation	A lobby, hallway or stairway that directly serves an Assembly room or rooms as an extension of the activities in those rooms.
615.3	Assignable Restroom	A toilet room that directly serves an Assembly room or rooms as an extension of the activities in those rooms. This is a private toilet room with restricted access – and it is not accessible to the general public.

615.8	Kitchenette	Kitchenette that directly serves an assembly room or rooms as an extension of the activities in those rooms
620	Exhibition	A room or area used for exhibition of materials, works of art, artifacts, etc., and intended for general use by faculty, students, staff, and the public.
625	Exhibition Service	A space that directly serves an exhibition facility as an extension of the activities in that facility.

630	Food Facility	A space used for eating.
630.1	Dining Hall Seating	A space within a dining hall used for eating. i.e. a seating area.
630.2	Café Seating	A space within a café used for eating i.e. a seating area.
630.3	Shop Kitchen and Dining	A space with kitchen and seating facilities for food assembly and consumption - shop personnel only.

650	Lounge	A space used for rest and relaxation that is not restricted to a specific group of people, unit, or area.
655	Lounge Service	A space that directly serves a general use lounge facility.
660	Merchandising	A space used to sell products or services.
665	Merchandising Service	A space that directly serves a merchandising facility as an extension of the activities in that facility.
670	Recreation	A space used by students, staff, or the public for recreational purposes
675	Recreation Service	A space that directly serves a recreation facility as an extension of the activities in that facility.
680	Meeting Room	A room that is used by the institution or the public for a variety of nonclass meetings.
685	Meeting Room Service	A space that serves a meeting space as an extension of the activities in that space.

700	Support Facilities	Support facilities, which provide centralized space for various auxiliary support systems and services of a campus, help keep all institutional programs and activities operational. While not as directly accessible to institutional and community members as General Use Facilities (Code 600 series), these areas provide a continuous, indirect support system to faculty, staff, students, and the public. Support facilities are centralized in that they typically serve an area ranging from an entire building or organizational unit to the entire campus. Included are centralized areas for computer-based data processing and telecommunications, shop services, general storage and supply, vehicle storage, central services (e.g., printing and duplicating, mail, shipping and receiving, environmental testing or monitoring, laundry, or food stores), and hazardous materials areas.
710	Central Computer or Telecommunications	A space used as a data or telecommunications center with applications that are broad enough to serve the overall administrative or academic primary equipment needs of a central group of users, department, college, school, or entire institution.
715	Central Comp. or Telecommunications Service	A space that directly serves a central computer or telecommunications facility as an extension of the activities in that facility.
720	Shop	A space used for the manufacture, repair, or maintenance of products or equipment.
725	Shop Service	A space that directly serves a shop facility as an extension of the activities in that facility.
730	Central Storage	A space or building that is used to store equipment or materials and that serves multiple space use categories, organizational units, or buildings.
735	Central Storage Service	A space that directly serves a central storage facility as an extension of the activities in that facility.
740	Vehicle Storage	A space or structure that is used to house or store vehicles.
745	Vehicle Storage Service	A space that directly serves a vehicle storage facility as an extension of the activities in that facility.
750	Central Service	A room or area that is used for the processing, preparation, testing, or delivery of a complex-central or campus-wide support service.

755	Central Service	A space that directly serves a central service facility as an extension of the activities in

780	Unit Storage	A dedicated storage area or location under the direct control and management of a specific institutional division, department, office, business unit, or similar organizational unit.

800	Health Care Facilities	This series provides space use classifications for patient care areas that are located in separately organized and budgeted health care facilities: student infirmaries and centers, teaching hospitals, stand-alone clinics run by these hospitals, and veterinary and medical schools. Space codes and definitions apply to both human and animal health care areas; excluded are clinic facilities located outside of separately organized and budgeted health care facilities (see Clinic-540). Although the codes in this series are confined to the settings listed, these facilities may also house areas that are classified using applicable codes from other classification series (e.g., classroom, laboratory, office, special use, general use, supporting facilities, etc.).
830	Nurse Station	A room or area used by nurses or other patient care staff who are supervising or administering health care services.
835	Nurse Station Service	A space that directly serves one or more nurse station spaces as an extension of the activities in those spaces.
850	Treatment/Examinat ion Clinic	A space used for examinations, diagnosis, consultation, or treatment.
855	Treatment/Examinat ion Clinic Service	A space that directly serves a Treatment/Examination Clinic room as an extension of the activities in those spaces.
860	Diagnostic Service Laboratory	A space used to provide diagnostic support services to an entire health care facility.
865	_	A space that directly serves a diagnostic service laboratory as an extension of the activities in that facility.
870	Central Supplies	A room used centrally to store health care supplies in a health care facility.
880	Public Waiting	A space used by the public to await admission, treatment, or information within a health care facility.

900	Residential Facilities	Residential facilities include housing for students, faculty, staff, and visitors to the institution. Hotel or motel and other guest facilities are included in this series if they are owned or controlled by the institution and used for purposes associated with defined institutional missions (i.e., excluding commercial investment). Note: Not all space in residential facilities is coded using the 900 series. Conventional primary activity and service codes, as with libraries, apply to specific areas. Included are Offices (310), Lounges (650), Study Rooms (410), dining areas (see Food Facility-630), Recreation (670) rooms, and their corresponding service codes. Service rooms that typically appear in residential facilities are specified in the Sleep/Study Service (935) or Apartment Service (955) descriptions.

W01	Bridge/Tunnel;	A covered and walled connecting passageway for people to pass over or under the ground to gain access to another facility.
W02	Elevator	The structural shaft built to accommodate one or more elevator cabs. The entire cross-sectional shaft area is to be inventoried at each floor level through which it passes.
W04	Loading Dock	A covered area of a platform used to load or off-load goods or materials that are to be transported elsewhere within a reasonable amount of time such that the platform is not considered as a storage location. Only the length and width of the platform's covered area is to be included in the inventory. If the platform is internal to the building line, that area of the platform covered by the floor immediately above is to be included in the inventory.
W05	Lobby	A circulation area used to transition from the floor's external entrance to internal circulation space, to pass from one corridor to another, or to move to a different level such as a lobby area outside an elevator bank. Although a Lobby may have some limited seating furniture, it is designed more for passing through (or having standing conversations) than for sitting and relaxing.
W06	Public Corridor	A covered passageway or ramped area available to the general public, whether walled or not, to transport people or things from one location to another. The use of phantom walls is recommended to identify portions of passageways on the same floor level that may represent differing purposes, e.g., a main corridor versus a side corridor, or differing maintenance needs, e.g., terrazzo flooring versus carpeted flooring.

W07	Stairway	The covered internal or external space dedicated to provide nonmechanically assisted passage from one floor level to another. In an enclosed stairway, the crosssectional area of the stairwell is inventoried at each floor through which it passes. In an unenclosed stairway, only that area beneath the stairway structure that is not accessible or has less than a 3-foot ceiling height is included.

Y02	Fuel Room	A room or area within a building in which fuel for the heating/cooling of the building is stored.
Y03	Shaft	Included are accessible or nonaccessible shaft spaces available to house utility pipes and cables, or to distribute air within or to the exterior of a building. The cross-sectional area of every shaft is to be inventoried at each floor level through which it passes.
Y04	Utility - Mechanical Space	Included are covered and walled areas that house one or more utility and/or mechanical functions for the building. These areas range from large rooms co-located on a "mechanical" floor or basement area to small closet spaces distributed throughout the building. Such areas, while generally located within the exterior walls of a building or as an accessible roof structure, may be separately housed adjacent to the structure that they serve. They include such areas sometimes referred to as electrical, meter, network, or telecommunication spaces. Some may prefer to identify these specific spaces separately and may do so by adding them as subcategories of this space use.
